AlphaBioCoat precoated T-25 Flasks with vented caps have a uniform and consistent application of high-quality AlphaBioCoat solution (cat. AC001) on a clear polystyrene surface. Flasks have an anti-drip edge and modified canted neck to provide maximum control replacing nutrient depleted media. The flasks have an anti-tip feature and specially shaped pouring channel for improved handling. Flasks are aseptically processed and are non-pyrogenic. Flasks are available in quantities of 10 flasks per sleeve.

#### NOTE: Flasks need to be rinsed with 1X media or PBS prior to seeding cells.

All procedures should be done under sterile conditions using aseptic techniques. Flasks must be rinsed with 1X media or PBS prior to seeding cells. Precoated flasks have a minimum shelf life of 6 months from the date of receipt and can be stored from 2-30°C. Flasks are shipped at room temperature.
